IMPACT ON Job Seekers The FWDB serves jobseekers, youth and businesses in the cities of Arcadia, Duarte, Monrovia, Pasadena, Sierra Madre & South Pasadena

Monrovia has 37,931 Residents. November 2021 Unemployment Rate – 5.9% FWDB Avg Unemployment Rate – 6.3%

# IMPACT ON Job Seekers

Customer Choice: Jobseekers (Adults, Dislocated Workers, Youth) may choose any America's Job Center of California (AJCC) for services

Monrovia customers may continue to use FWDB's Pasadena comprehensive AJCC. If budget constraints, FWDB may restrict training services to FETC/FWDB residents

### **IMPACT ON MONROVIA BUSINESS CUSTOMERS**



Monrovia businesses still use CalJOBS.org to recruit candidates



Training Programs - FWDB AJCC may still assist Monrovia businesses to place candidates, provide customized & on-the-job trainings if budget is available However business will be referred to its own local area first Monrovia businesses may use LA County WDB AJCCs and affiliate sites - nearest to Monrovia are affiliate sites: Alhambra Affiliate AJCC & Baldwin Park Affiliate AJCC



Rapid Response services for Monrovia businesses will be coordinated by Los Angeles County and its AJCCs

# **IMPACT TO FETC POLICY BOARD**



Monrovia no longer on FETC Policy Board & membership becomes five cities: Arcadia, Duarte, Pasadena, Sierra Madre, South Pasadena



Policy Board quorum becomes three members



FETC Joint Powers Agreement may be changed



Monrovia will be represented on LA County WDB along with 55 cities & 150 unincorporated areas representing the four million residents of the areas of LA County it serves

## **IMPACT TO FWDB BOARD**

FWDB will restructure membership to focus private sector membership to remaining five cities' businesses & employers Existing WIOA and State requirements (private sector majority, Labor representation and other mandated partners) do not change

MOUs with partners may be modified

Monrovia Community Adult School would no longer be primary Adult Education partner. Would still be utilized training programs via I-Train
